

# FOOD SAFETY TRAINING FOR AUDITOR UNDER ACB-HACCP SCHEME



## INTRODUCTION

Food safety training for auditor is one of the requirement under accreditation scheme, Standards Malaysia for the accredited certification bodies (ACB) conducting auditing and certification for Hazard Analysis And Critical Control Point (ACB-HACCP): MS 1480 for Food Sectors, as well as Food Safety Management System (FSMS).

The training course shall be conducted by trainer certified by Ministry Of Health (MOH). This course comprises of two components, lecture and examination. A certificate of the training will only be awarded to participants who passed the examination.

This course is also opened to those interested in gaining more knowledge in HACCP. However, it is not a course for recognition as an auditor or consultant under MOH.
