INTRODUCTION

Food Defense Certification is a new certification scheme under the Food Safety and Quality Program, Ministry of Health Malaysia.

The certification provide written assurance that the food defense plan implemented in the food premises conform to food defense certification requirements.

It may provide an official endorsement to the certified party as products manufactured or distributed have been produced by the manufacturing company under controlled and protected condition.

In term of food safety along the supply chain, storage of raw material and final product are adequately protected from elements of sabotage or intentional undesired faulty adulteration and fraud attempt.

This course may later enhance the protection and monitoring of system readily implemented by manufacturers and may offer defensive mechanism for any ill intended elements towards affected product.
