## INTRODUCTION

*Food Safety Training for Auditor is one of the requirement for the accreditation bodies operating certification of Good Manufacturing Practice (ACB-GMP) for food sector under Standards Malaysia.*

*Under Clause 3.2.3 Scheme for the Accreditation of Certification Bodies, Department of Standards Malaysia, 2013 - The certification body shall ensure that auditors have successfully completed training in good hygiene practice, GMP/HACCP and food hygiene requirements. The training course shall be conducted by trainer certified by Ministry of Health (MOH).*

*This course comprises of two components, lecture and examination. A certificate of the training will only be awarded to participants who passed the examination*
